Maintain accurate HSE documentation, records, statistics, and reports, including TRIR, LTIF, and safety performance indicators. Promote a strong safety culture by coaching, mentoring, and motivating the workforce to follow safe work practices. Supervise and support junior HSE staff, safety officers, and site supervisors to ensure effective HSE implementation across all operations. Ensure environmental protection measures are implemented, including waste management, spill prevention, pollution control, and environmental monitoring.
