Coordinated closely with wireline, slickline, coiled tubing, cementing, and well intervention service providers to ensure proper execution of planned programs. Led HSE implementation at the well site by enforcing Permit to Work (PTW) systems, Job Safety Analysis (JSA), toolbox talks, and risk assessments. Ensured all personnel were certified, competent, and fit for work, and actively promoted a strong safety culture to prevent incidents and non-productive time. Prepared and submitted accurate daily drilling and workover reports, monitored operational performance, analyzed non-productive time (NPT), and communicated effectively with engineering, geology, production, and management teams to optimize operational efficiency, reduce risk, and ensure safe delivery of wells from spud to final handover.
